THE HARYANA VALUE ADDED TAX (SECOND AMENDMENT) ACT, 2014

ACT

further to amend the Haryana Value Added Tax Act, 2003.

BE it enacted by of the Legislature of the State of Haryana in the Sixty-fifth Year of the Republic of India as follows: -

- 1. This Act may be called the Haryana Value Added Tax (Second Short title. Amendment) Act, 2014.
- 2. After section 59 of the Haryana Value Added Tax Act, 2003, the Insertion of following section shall be inserted, namely:-

section 59A in Haryana Act 6 of

- "59A. Amnesty Scheme.—Notwithstanding anything to the 2003. contrary contained in this Act and rules made thereunder, the Government may, by notification in the Official Gazette, notify amnesty scheme for recovering old arrears of taxes which are outstanding and are difficult to recover inspite of various efforts, for the period prior to 1st April, 2014, subject to such conditions and restrictions, as may be specified in the scheme.".
- 3. (1) The Haryana Value Added Tax (Amendment) Ordinance, 2014 Repeal and (Haryana Ordinance No. 7 of 2014) is hereby repealed.

(2) Notwithstanding such repeal, anything done or any action taken under the said Ordinance, shall be deemed to have been done or taken under this Act.
