GOVERNMENT OF HARYANA EXCISE & TAXATION DEPARTMENT

NOTICE FOR INVITING e-TENDERS FOR ALLOTMENT OF LICENSES FOR ZONES OF COMPOSITE RETAIL VENDS OF COUNTRY LIQUOR (L-14A) AND INDIAN MADE FOREIGN LIQUOR (L-2) FROM THE GENERAL PUBLIC FOR THE YEAR 2019-20 IN THE STATE OF HARYANA.

1. It is hereby notified for the information of general public that e-TENDERS for allotment of Zones of composite vend of Country Liquor (L-14A) and IMFL (L-2), are invited for the year 2019-20. The Zone of composite retail vend shall be allotted to the highest eligible bidder, quoting equal to or above the reserve price of the Zone. In case of more than one bid quoting the same highest price, the allottee shall be determined by draw of lots among the bidders quoting the same highest price. A zone shall comprise of maximum of (6) contiguously located retail vend of CL only or IMFL only or CL and IMFL both.
2. The licensee shall have flexibility to decide the type of vend i.e CL only or IMFL only or both CL and IMFL subject to the overall limit of vend allotted to the Zone. He will also have the flexibility to locate these retail vend within the command area of Zone subject to the compliance of provisions of Excise Policy 2019-20 or any other law applicable, wherever required.
3. The annual quota of CL and IMFL of the Zone, the command area, number of retail vend in the Zone as well as its Reserve Price shall be provided in the excise arrangements which are available in the office of the Deputy Excise and Taxation Commissioners (Excise) concerned and on the departmental website www.haryanatax.gov.in
4. In order to submit e-bids, every prospective bidder is required to register themselves with the department. The detailed procedure for registration and placing the e-tenders and submission of participation fee and earnest money, in accordance with the Excise Policy 2019-20, is available on the website of the department www.haryanatax.gov.in as well as in all the Excise Offices of the Department.
5. A bidder can apply for any number of Zones of retail vend in any District of the State. The persons applying for allotment of Zone of vend against reserved category shall have to submit necessary caste certificate in the office of DETC (Excise) concerned at the time of furnishing documents, failing which their e-tenders shall be liable to be rejected.
6. All licenses shall be granted subject to the Punjab Excise Act, 1914 (as applicable to the State of Haryana) and the Rules framed there-under and the Excise Policy for the year 2019-20. The Excise Policy 2018-19 is available on the official website of the Department www.haryanatax.gov.in.
7. The e-bids can be placed any time round the clock after the starting date and time as per the schedule given hereunder, and upto the closing time of the closing date. For the purpose of setting the time, it shall be as per the Server time of State Data Centre of Haryana.

The schedule of placing e-bids and evaluation thereof is as follows:-

- **Group A** includes the following seven districts: Bhiwani, Gurugram (East), Gurugram (West), Hisar, Palwal, Panchkula and Sonapat.

- **Group B** includes the following eight districts: Panipat, Faridabad, Karnal, Kaithal, Narnaul, Jhajjar, Jagadhri and Mewat.
- **Group C** includes the following seven districts: Ambala, Jind, Fatehabad, Kurukshetra, Rewari, Sirsa and Rohtak.

6.	Evaluation of e-tenders for Group B districts	16 th March, 2019 (6:00 pm)
7.	Starting date and time for placing e-tenders in respect of districts falling in Group C	From 18 th March 2019 (9:00 am)
8.	Closing date and time for placing e-tenders in respect of districts falling in Group C	Till 19 th March, 2019 (5:00 pm)
9.	Evaluation of e-tenders for Group C districts	19 th March, 2019 (6:00 pm)

Note: In case the successful bidder fails to deposit the 5% of the bid amount on the due date, his bid shall be deemed to have been cancelled and earnest money deposited by him shall be forfeited and such bidder shall be blacklisted for five years. Further, the allotment of such group/vend would be done by inviting e-tenders as in case of unallotted groups/vends.
