- These e-Tenders will be submitted online as per procedure given in public notice issued by the Department (**published on 09th March, 2019**) in the leading newspapers inviting e-Tenders for allotment of retail liquor licenses of Zones of vendes for the year 2019-20. The said public notice is available on the departmental website i.e. www.haryanatax.gov.in.
- The list of rejected/un-allotted Zones of vendes in the Districts Gurugram (East), Gurugram (West) and Kaithal and venue for evaluation of e-Tenders shall be conspicuously displayed in

the office of DETC (Excise) & DETC (ST) concerned. The list shall also be available on the departmental website i.e. www.haryanatax.gov.in.

3. The e-Tenders shall be received and the Zones of vends shall be allotted in the manner prescribed in the Excise Policy for the year 2019-20 and the Punjab Excise Act, 1914 (as applicable to the State of Haryana), the rules framed thereunder.
4. The relevant provisions contained in the previous Public Notices issued for allotment of vends for the year 2019-2020 shall hold good and are not reiterated. **However, the reserved zones, if any, shall stand in reserved category in case of rejected zones. Beside this, the un-allotted reserved zones, if any, shall stand de-reserved and shall be available in the General category.**
5. The allotment shall be subject to the approval of the Excise and Taxation Commissioner, Haryana. He may reject, without assigning any reason, any allotment in public interest as the case may be within 10 days of the date of allotment.
