

**HARYANA GOVERNMENT

NOTIFICATION**

No. S.O. 8 /H.A.13/2000/S.11/2003. – In exercise of the powers conferred by sub-section (1) of section 11 of the Haryana Local Area Development Tax Act, 2000 (Act 13 of 2000), and all other powers enabling him in this behalf and in supersession of Haryana Government, Prohibition, Excise and Taxation Department, notification No. S.O. 113/H.A. 13/2000/S.11/2000, dated the 29th September, 2000, the Governor of Haryana being of the opinion that it is necessary so to do in public interest, hereby exempts with effect from the date of publication of this notification in the Official Gazette, a works contractor from the tax payable under the said Act in respect of entry of such goods except petrol, High Speed Diesel, Super Light Diesel Oil and Light Diesel Oil in a local area in the State used or consumed therein in execution of a works contract, on the value of which, as part of the value of the works contract, he pays lumpsum in lieu of sales tax under the provisions of sub-section (2) of section 26 of the Haryana General Sales Tax Act, 1973 (Act 20 of 1973).
