HARYANA ACT NO. 18 OF 2011

**THE PUNJAB PASSENGERS AND GOODS TAXATION
(HARYANA AMENDMENT) ACT, 2011**

AN

ACT

further to amend the Punjab Passengers and Goods Taxation Act, 1952, in its application to the State of Haryana.

Be it enacted by the Legislature of the State of Haryana in the Sixty-second Year of the Republic of India as follows: —

Short title.

1. This Act may be called the Punjab Passenger and Goods Taxation (Haryana Amendment) Act, 2011.

Amendment of section 9 of Punjab Act 16 of 1952.

2. In sub-section (1) of section 9 of the Punjab Passengers and Goods Taxation Act, 1952, for the words "of five rupees" existing at the end, the words "as prescribed" shall be substituted.
