NOTICE FOR INVITING SEALED TENDERS FROM THE GENERAL PUBLIC FOR ALLOTMENT OF REMAINING RETAIL LIQUOR LICENSES OF COUNTRY LIQUOR (L-14A) AND IMFL (L-2) IN THE DISTRICTS MENTIONED BELOW FOR THE YEAR 2011-2012 IN THE STATE OF HARYANA.

It is hereby notified for the information of general public that SEALED TENDER applications for allotment of **all remaining** retail outlets of Country Liquor (L-14A) and IMFL (L-2) for the year 2011-2012 in the Districts as mentioned below are invited:-

- (i) (a) Date of receipt of Tender Forms in the districts of Gurgaon, Sirsa, Narnaul, Hisar, Jind, Kaithal, Ambala, Karnal, Panipat, Yamuna Nagar & Jhajjar : **18th to 21st March, 2011 (Except Sunday i.e. 20.03.2011) from 10.00 A.M. to 5.00 P.M.**
- (b) Date of opening of Tender Forms : **22nd March, 2011 at 9.00 A.M.**
- (ii) (a) Date of receipt of Tender Forms in the districts of Faridabad, Mewat, Rewari, Bhiwani, Fatehabad, Sonapat, Kurukshetra, Panchkula, Rohtak & Palwal : **19th to 22nd March, 2011 (Except Sunday i.e. 20.03.2011) from 10.00 A.M. to 5.00 P.M.**
- (b) Date of opening of Tender Forms : **24th March, 2011 at 9.00 A.M.**

(On last day, in each district, all in queue at 5.00 P.M. will be allowed to submit their bid and will be given chits to ensure the submission of bid by DETC(X)).

The tenders shall be opened in the office of DETC(Excise) concerned in the presence of the Committee.

The vend shall be operated w.e.f. **1st April, 2011.**

The list of vends in these Districts shall also be displayed in the office of DETC (Excise) & DETC(ST) concerned.

The sealed tenders shall be received and the vends shall be allotted in the manner prescribed in the Excise policy 2011-2012, Instructions issued and previous Public Notices issued for allotment for the year 2011-2012.

The relevant provisions contained in the previous Public Notices issued for allotment of vends for the year 2011-2012 shall hold good and are not reiterated.

All licenses shall be granted subject to the Excise Policy for the year 2011-12 and the Punjab Excise Act, 1914 (as applicable to the State of Haryana) and the rules framed thereunder.

All allotments shall be subject to the approval of the Excise and Taxation Commissioner, Haryana. He may reject, without assigning any reason, any allotment in public interest as the case may be within 10 days of the date of allotment.
