1. *These e-Tenders will be submitted online as per the public notice issued by the department (published on 6th March, 2015 in the leading Newspapers) inviting e-Tenders for allotment of retail liquor licenses of country liquor and IMFL for the year 2015-16. 2. *The list of remaining groups of vends in the Districts (Group A) shall be conspicuously displayed in the office of DETC (Excise) & DETC (ST) concerned. The list shall also be available on the departmental website i.e. www.haryanatax.com.*
3. *The venue for the evaluation of the e-Bids in the respective districts shall be displayed in the office of DETC (Excise) & DETC (ST) concerned. The list shall also be available on the departmental website i.e. www.haryanatax.com.*
4. *The e-Tenders shall be received and the groups of vends shall be allotted in the manner prescribed in the Excise Policy for the year 2015-16 and the Punjab Excise Act, 1914 (as applicable to the State of Haryana) and the rules framed thereunder,*
5. *The relevant provisions contained in the previous Public Notices issued for allotment of vends for the year 2015-2016 shall hold good and are not reiterated. **However, now the un-allotted reserved groups shall stand de-reserved and shall be available in the General category.***
6. *All allotments shall be subject to the approval of the Excise and Taxation Commissioner, Haryana. He may reject, without assigning any reason, any allotment in public interest as the case may be within 10 days of the date of allotment.*
