#### **NOTICE FOR INVITING e-TENDERS FOR ALLOTMENT OF REMAINING RETAIL LIQUOR LICENSES OF LEFTOVER ZONES OF LIQUOR VENDS OF TEN (10) DISTRICTS OF GROUP-A, GROUP-B & GROUP-C FROM THE GENERAL PUBLIC FOR THE YEAR 2017-18 IN THE STATE OF HARYANA.**

It is hereby notified for the information of general public that e-TENDERS for allotment of all the remaining Zones of retail liquor vendes in **Ten (10) districts of Group-A, Group-B & Group-C**, are invited for the year 2017-2018. The reserve prices of the un-allotted Zones have been further reduced from the previous round of allotment by a successive reduction of 5% of the original reserve price or Rs. 25 Lac, whichever is lower. The district wise list of un-allotted Zones, in the form of Excise Arrangement, is available on the official website ([www.haryanatax.gov.in](http://www.haryanatax.gov.in)) of the department.

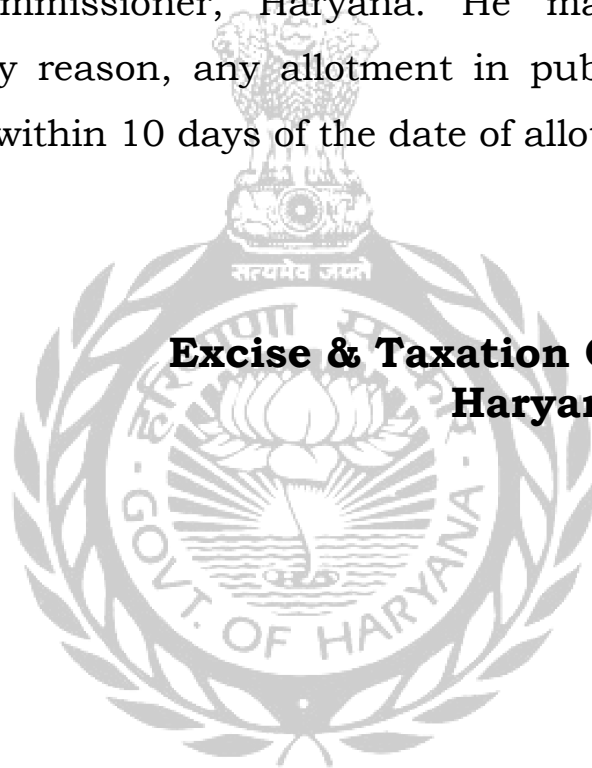
#### **Note:-**

- Group-A, Group-B & Group-C The **Ten (10)** districts wherein some Zones of retail liquor vendes remained unsold in the Group-A, Group-B & Group-C are:- Fatehabad, Jhajjar, Jind, Kaithal, Karnal, Panipat, Rewari, Rohtak, Sirsa and Sonapat.

#### **Schedule for invitation and evaluation for e-Tenders for remaining Zones of retail liquor vendes (Group - A, B & C)**

1.	Starting date and time for placing e-tenders in respect of leftover Zones of retail liquor vendes (Group A, B & C) of <b>Ten (10)</b> districts.	From 25 <sup>th</sup> April, 2017 (9:00 A.M.)
2.	Closing Date and time for placing e-tenders in respect of leftover Zones of retail liquor vendes (Group A, B & C).	Till 25 <sup>th</sup> April, 2017 (4:00 P.M.)
3.	Evaluation of e-tenders of leftover Zones of retail liquor vendes (Group A, B & C).	<b>25<sup>th</sup> April, 2017</b> <b>(6:00 P.M.)</b>

1. The procedure for placing e-bids is available on the official website i.e. [www.haryanatax.gov.in](http://www.haryanatax.gov.in).
2. The allotment shall be made in accordance with and subject to the provisions of the Punjab Excise Act, 1914 (as applicable to the State of Haryana), rules framed thereunder and the Excise Policy for the year 2017-18.
3. The relevant provisions contained in the previous Public Notices issued for allotment of Zones of vends for the year 2017-2018 shall hold good and are not reiterated.
4. All allotments shall be subject to the approval of the Excise and Taxation Commissioner, Haryana. He may reject, without assigning any reason, any allotment in public interest as the case may be within 10 days of the date of allotment.
