NOTICE FOR INVITING E-TENDERS FROM GENERAL PUBLIC FOR RE-ALLOTMENT OF ZONES OF RETAIL LIQUOR VENDS OF DISTRICT KAITHAL, HARYANA FOR THE REMAINING DURATION OF EXCISE POLICY YEAR 2021-22.

It is hereby notified for the information of general public that e-Tenders for re-allotment of 3 zones of Retail liquor Vends of district Kaithal, as mentioned below, are invited for the remaining duration of excise policy year 2021-22.

2. The schedule for submission of e-Tenders and evaluation thereof shall be as under:-

1	Starting date and time for placing e-tenders.	From 29 th April, 2022 (10:00 A.M.)
2	Closing Date and time for placing e-tenders.	Till 29 th April, 2022 (02:00 P.M.)
3	Evaluation of e-tenders.	29 th April, 2022 (02:30 P.M.)

3. The e-Tenders will be submitted online as per Public Notice issued by the Department **(published on 01st June, 2021)** in the leading newspapers for inviting e-Tenders for allotment of retail liquor licenses of Zones of vendes for the year 2021-22. The willing persons shall be required to register themselves online. The Public Notice and detailed procedure for registration is available on the departmental website i.e. www.haryanatax.gov.in. The interested bidders may also obtain copy of instructions from the office of DETC (X), Kaithal.

4. The list of Zones of vendes in the District and Venue for evaluation of e-Tenders shall be conspicuously displayed in the office of DETC (Excise) and DETC (ST) concerned. The list shall also be available on the departmental website i.e. www.haryanatax.gov.in. Any further clarification in this regard may be obtained from the office of DETC (X), Kaithal.

5. The allotment shall be valid for the period from date of allotment to last day of excise year 2021-22 i.e. 11.06.2022, subject to provisions of the Haryana Excise Act, 1914, rules framed thereunder and the instructions issued from time to time.

6. The reserve price and quota of CL & IMFL of the above mentioned zones for remaining period of allotment is available in the excise arrangement uploaded on the department website and it will also be pasted on Notice Board in the office of DETC (X) and DETC (ST). Any further clarification may be obtained from the office of DETC (Excise).

7. The earnest money shall be payable as per clause 2.15 of the Excise Policy for the year 2021-22. The schedule for depositing the security and license fee shall be as under:-

Security 20% of bid amount	On the day of opening of bid/evaluation of e-tender i.e. 29.04.2022.
1 st Installment of license fee i.e. 30% of bid amount	-do-
2 nd Installment of license fee i.e. 28% of bid amount	Within 7 days of allotment
3 rd /Final Installment of license fee i.e. 25% of bid amount	13 th May, 2022

8. The CL & IMFL quota shall be equal to the unutilized basic quota of the respective zones and shall be reflected in the excise arrangement. The licensee will be allowed to lift basic quota of CL & IMFL in proportion to the license fee deposited by him. The licensee shall also be allowed to lift additional quota upto 50% of basic quota as per provisions of the excise policy. For any further detail regarding these zones, kindly see the excise arrangement duly uploaded on departmental portal.
9. The remaining terms and conditions of allotment shall be as per excise policy.
10. The allotment shall be subject to the approval of the Excise and Taxation Commissioner, Haryana. He may reject, without assigning any reason, any allotment in public interest as the case may be within 10 days of the date of allotment.
