

BEFORE ASHUTOSH RAJAN, HCS, COLLECTOR (EXCISE)-CUM-JOINT EXCISE AND
TAXATION COMMISSIONER, HARYANA, PANCHKULA

Order

In the breach case of 2021-22 of
Sh. Akshay Kumar, L-2/L-14A Licensee,
Zone No. ZGRE55 (Gurugram Sohna Road, Sohna),
Gurugram (East).

Whereas, under the rule 36-A(25 and 26) of Haryana Liquor License Rules, 1970, the licensee was required to pay license fee in the installments as prescribed for the retail licensed outlets of Zone No. ZGRE55 (Gurugram Sohna Road, Sohna), Gurugram (East). But DETC(X), Gurugram (East) intimated that the licensee has failed to deposit the license fee amount of Rs. 35,60,443/- for the months of February and March, 2022 of the above mentioned Zone.

2. A notice was issued to the licensee to show cause as to why his license should not be cancelled u/s 36(b) of the Punjab Excise Act, 1914 and security forfeited u/r 37(36) of the Haryana Liquor License Rules, 1970 (hereinafter referred to as the Rules) for having contravened the provisions of rule 36-A(25 and 26) of Haryana Liquor License Rules, 1970 and condition No. 6.4 of the Haryana Excise Policy for the year 2021-22. The notice was served upon the licensee on 03.05.2022 through which he was directed to appear before the undersigned in person or through his legal representative on 04.05.2022 to submit reply in this regard.

3. Neither the licensee/ his representative appeared before the undersigned nor he submitted any reply in response to the notice. However, the due license fee has not been deposited till date. Thus, after considering all the facts and circumstances narrated above, I have reasons to believe that the licensee has committed the irregularity mentioned in para 1 above.

4. Accordingly, I cancel the license of Sh. Akshay Kumar, L-2/L-14A Licensee, Zone No. ZGRE55 (Gurugram Sohna Road, Sohna), Gurugram (East) under section 36(b) of the Act and forfeit the amount of security already deposited by licensee under rule 37(36) of the Rules.
