

ORDER

The State Election Commission, Haryana, has issued election schedule for conducting general elections of 08 Municipal Corporations, 04 Municipal Councils and 21 Municipal Committees in the State in addition to bye-elections for 04 posts of Mayors of Municipal Corporations, Ambala and Sonapat; Presidents of Municipal Committee Assndh (Karnal); Municipal Committee, Ismailabad (Kurukshetra) and some other municipal bodies' bye-elections as per list enclosed. The polling of votes in these municipal bodies (except Municipal Corporation, Panipat) will be held on 02nd March, 2025. Polling of votes for Municipal Corporation, Panipat will be held on 09, March, 2025.

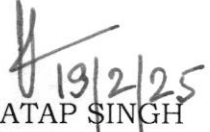
Whereas no liquor shops, hotels, restaurants, clubs and other establishments selling/serving liquor located in the different areas of Municipal Local Bodies where election are going to be held, shall be permitted to sell/serve liquor to anyone whosoever on polling days and counting days.

Therefore, I, Vinay Pratap Singh, IAS, Excise and Taxation Commissioner, Haryana, Panchkula in pursuance of the provisions of rule 37(10) of the Haryana Liquor License Rules, 1970 hereby order that the liquor vends and all other excise establishments like wholesalers, bars, pubs, microbreweries etc. located within Municipal Local Bodies area where elections are scheduled to be held and three Kilometers adjoining to such areas in the State of Haryana, shall remain closed as per following schedule:-
